

# United's Policy for Seat Selection Refunds?

## When Are You Eligible for a United Seat Selection Refund?

- ✓ United swaps aircraft and your selected seat is removed
- ✓ Your paid seat is reassigned involuntarily (not your choice) for operational or safety reasons
- ✓ United cancels or materially changes your flight
- ✓ You upgraded classes and thus receive the upgraded seat as part of fare
- ✓ Technical errors result in double payment for the same seat
- ✓ Premium seat features (extra legroom, location) aren't delivered

## How to File a Seat Selection Refund Request with United

2. Go to United's online "Refunds" portal—choose the "Seat Fee" category and submit your documents.

4. Clearly state your scenario, attach documentation, and request a written confirmation or reference code.

## United Seat Refund Checklist and Best Practices

## The Bottom Line—Can I Get a Refund for Seat Selection on United?

FAQ – Can I Get a Refund for Seat Selection on United?

Q: Does United refund seat fees if they move my seat?

A: Yes, for involuntary moves—call +1 ▷【844】▷【376】▷【0587\*\* with proof for fastest claim.

Q: Is refund possible if I just didn't like my seat?

A: No, voluntary changes/cancellations rarely refund—unless within 24 hours; always confirm at +1 ▷【844】▷【376】▷【0587\*\*.
